3 · PRODUCT INFORMATION

3.1 · DESCRIPTION OF THE PRODUCT

2DR1 Motor Unit has been design to be a track drive system for medium/heavy weight curtains. The drive pulley operates the hauling line to which the curtain/scenery element is connected. The speed of the rope is adjustable up to a maximum of 0.9 m/s. The Motor Unit can be controlled via DMX as an option.

Simple and compact, 2DR1 can be installed directly beneath a track and it is compatible with straight and curved track layouts.

3.2 · INTENDED/UNINTENDED USE

2DR1 Motor Unit is designed and approved for operating curtain track system produced by Peroni S.p.A. It allows to move horizontally curtains and other scenery elements of medium/heavy weight.

Peroni S.p.A. accepts no claims for liability if the equipment is used in any other way.



WARNING: Any other use is strictly prohibited. It can result in severe injury to personnel and/or may cause material damage.



WARNING: Do not use 2DR1 Motor Unit for lifting.



WARNING: Do not use 2DR1 Motor Unit for suspending or moving people/animals.

3.3 · WARRANTY AND LIABILITY

Peroni S.p.A. guarantees its products against materials and manufacturing defects for two years from the date of the invoice. At its sole discretion, Peroni S.p.A. will repair or replace the defective product free of charge.

The warranty applies only to Peroni S.p.A. products and cannot be extended to the project in which they are installed.



5 · TRACK MOUNTING

The 2DR1 Motor Unit is designed to be bolted directly beneath the track using a support plate.


It is recommended the presence of a second person throughout the entire installation, who can provide assistance in the case of need.

1. Place the support plate onto the track.

Thanks to the channel nuts, the plate can slide forward and backward if you need to adjust its final position.

Slowly rotate the screws. The channel nuts should turn 90 degrees into the channel and fit into fixing position.


Keep on tightening the screws to completely fasten.



2. Be sure to place two suspension points (one by each side of the plate) to support the weight of the motor unit and the stress of the cord pulling.




DO NOT hang the motor unit onto a cantilever track section!




3. With the help of a second person, lift the motor unit just beneath the track and tighten the four securing screws to fix it in position to the support plate.



CAUTION: Before suspending the 2DR1 Motor Unit, ensure the track is securely attached to a stable and horizontal supporting structure.



4. Put the head pulley into position. Check and correct the alignment of the pulley before fastening it.




6 · THREADING THE ROPE

2DR1 Motor Unit is designed to operate with 8 mm diameter polyester rope as a means to transmit the motion. This textile rope is subject to a natural elongation under tensile load due to its elasticity and the arrangement of the fibres. For this reason the motor unit is equipped with a spring system to compensate the elongation of the rope.


Please follow the steps below to thread the rope through out the tensioning pulley system of the motor unit.




CAUTION: Before starting, make sure the motor unit is NOT connected to the power supply to prevent unexpected start-up. Danger of hands or arms being drawn in and/or caught by moving parts!




1. Remove first the protective front cover by loosening the 4 screws.




2. Using the provided ratchet wrench, compress the spring mechanism until reaching the bottom position.




3. Thread the rope into one of the sheave of the head pulley, pass by the guide roller and proceed down around the rear groove of the drive sheave.



4. Turn around the tensioner idler pulley and then down into the front groove of the drive sheave.



5. Go up again through the head pulley, passing by the other small guide roller.



6. Loosen completely the threaded stud with the ratchet wrench and remove it. Place back the protective cover into place.

After a few cycles the spring mechanism will extend to compensate the elasticity of the rope. Once stabilized, the spring mechanism must remain partially compressed to work properly.

Ensure the rope is correctly tensioned! Depending on the frequency of use and the load applied, the rope may need re-tensioning. In this case ensure the motor unit is NOT connected to the power supply and follow the same procedure from step 1 to step 6.



ALERT! Remember to always place the protective cover after the cording procedure, then operate the product.


7 · LIMIT SWITCHES


2DR1 Motor Unit is supplied with two limit switches, one for the open and one for the closed position. The limit switches are mounted on the track and determine the maximum range of travel of the master carrier to which the limit striker is fitted.

The system shall always be able to stop smoothly and without any visible shock, it is therefore crucial to fit the limit switches in the right position to halt the motor running in good time.

The limit switches are pre-wired and equipped with plug connectors. The length of the cables is different for the two switches and is usually configured in factory taking into account the dimensions of the required track system:

- the longer one is for the CLOSED position and is placed near the centre of the track for traveller curtain or at the end opposite to the motor unit for wipe curtain
- · the shorter one is for the OPEN position and is placed in proximity of the motor unit, taking into account the stacking space of the curtain





Remember that the precise position of each limit switch depends on several factors which affect directly the stopping distances:


- · the length/weight of the curtain
- · the operating speed
- · the stop ramp managed by the inverter (default setting 0.5 sec)




ALERT! If you change any of these factors, you may need to adjust the position of the limit switches accordingly.



ALERT! Only one of the master carriers is equipped with the limit striker. Mounting the limit switch on the track, make sure the roller lever of the micro-switch is aligned with the striker fitted to the master carrier.

Note: the limit switches and the limit striker needs to be fitted on the same track of the motor unit.

8 · ELECTRICAL INSTALLATION




WARNING: Before starting the installation, secure the red main switch on the control panel is in the OFF (0) position and lock the emergency stop push-botton.

The factory assembled and tested 2DR1 system provides fast installation and startup at customer site. Cables are equipped with connectors making the electrical connection quick and safe.

Follow these simple steps as shown in the connection diagram below.

- Connect the limit switches to the motor unit
- 2. Connect the motor unit to the 2QE Control Cabinet via the extension cable
- 3. Connect the control cabinet to the mains supply (230VAC - 50 Hz). Be sure to install a motor rated circuit breaker on the supply.

Now the system is ready for testing.



TESTING OF THE SYSTEM

It is necessary to test the system to assure proper working of the limit switches.

- Ensure that no personnel or objects are in the working area of the curtain track system during the testing procedure. The operator must have a direct view of the movement of the device.
- 2. Turn the main switch on the control panel to position "I" and unlock the emergency stop push-button.
- Set a low speed by adjusting the potentiometer on the control panel.
- Start the system and be ready to operate the Emergency Stop push-button.
- Closely monitor the master carrier while approaching the limit positions. The motor unit should stop running when it reaches the Open/Closed limit position. In case of failure, disconnect the power supply and invert the connection of the limit switches to the motor unit.
- Check again the proper working of the limit switches.



In order to avoid any motor damage, the system shall always be able to stop smoothly and without violent impacts against other components. You may need to adjust the final position of the limit switched accordingly.

9 · MAINTENANCE

In general a 2DR1 system requires no special care, however some components may be subjected to wear over the time and periodical checks are recommended to avoid unexpected events.

A regular use is the best way to diagnosing and locating any faults or malfunctions, so we advise to operate the system at least once a month and always pay attention for unusual noise or vibrations.



WARNING: Before starting any maintenance intervention, disconnect power to the machine and secure all switches in the OFF position.

10 · TROUBLESHOOTING

Problem	Possible Cause	Corrective Action
Unusual noise/vibration	Release of threaded connections; Wear of the bearings	Check and tighten the threaded connections; Check and eventually replace the bearings
Failure to start	Improper power supply; Improper connection of the elements; Electrical fault of the control cabinet; Damaged electric cables; Excessive load	Check that mains assembly and service conditions comply with the information on the plate and described in the technical documentation. Repeat the assembly procedure, verify the position of the limit switches and check cables and connectors. Verify the weight of the curtain.
Failure to stop	Improper connection of the limit switches; Improper position of the limit switches; Electrical fault of the control cabinet	Repeat the assembly procedure, verify the position of the limit switches and check all the connectors are firmly tightened
Rope slippage or stall during operation	Excessive load; Loose rope	Adjust the tension of the rope; Reduce the load if possible
Rope slackening	Natural elongation of the cord fibres; Improper assembly of the rope	Follow the rope installation procedure again, adjust the tension and clamp the rope firmly
Irregular rope gliding/blocking	Improper assembly; Wear of the rope; Presence of knots; Excessive torsion	Check the rope for wear or knots, replace if necessary and repeat the assembly procedure

11 · RESIDUAL RISKS

Residual risks are special hazards involved in handling of the product which cannot be eliminated despite the safety-compliant design of the device. Residual risks are not obviously identifiable and can be a potential source of injury or health hazard.

12 · FINAL DECOMMISSIONING

2DR1 Motor Unit consists of mixed elements made of ferrous, non-ferrous, plastic materials and electric/electronic devices. Peroni S.p.A. recommends and encourages the end of life motor dismantling and the differentiation and recycling of the components.

The differentiated disposal of the motor components shall be performed with respect to the local regulations for the environment protection.

Separate and recycle the disassembled components:

- · Scrap metal materials
- · Recycle plastic elements
- · Sort and dispose of other component materials according to the applicable local regulations
- · Electric scrap, electronic components, lubricants and other utility materials must be treated as special waste and may only be disposed of by specialized companies
